If you are under the age of 18, you must have your parents or guardian agree to

these terms and conditions.

Competition Rules

- **1.** Eligibility
 - a. Age
 - i. No restrictions here
 - b. Team Size
 - i. Teams can be a maximum of 4 people.
 - c. Prior Projects
 - i. All projects must have at the earliest 3 months before the stated deadline.
 - ii. Prior work is not eligible for this competition.
 - iii. If we discover that you submitted prior work, you will be disqualified.
 - d. Number of Projects
 - i. Only one project can be submitted from this competition.
 - ii. If you are working solo, you can submit only once. If you are working in a group, you can only submit as part of the group, and you cannot submit another solo project or another group project.
- 2. Online Registration
 - a. Our requirements and online fields are shown via the Google Forms link available on the website.
- **3.** Project Parameters
 - a. You can use any language or framework.

- b. The app should be functional to be competitive.
- c. The work for the submission must be original. You or your group cannot copy code from other students. You can of course research widely known computer algorithms if needed such as binary search or merge sort, etc.
- **4.** Online submission
 - a. We strongly recommend that you have your project on Github and give us proper access rights, but this is not a requirement. However, if we ask you, then you agree that you must give us access and the link to your Github repository. Failure to do so may result in disqualification.
 - b. You can sign up at onewayhacks.com
 - c. A demonstration Video (5 minutes MAX) is required.
 - i. Names of the participants
 - ii. Project Name
 - iii. Clearly explain the purpose of the application
 - iv. Programming languages used
 - v. Show us how the app works. Show us its tools and features.
 - vi. You are not required in any way to show us your faces on the video.
- 5. DEADLINE
 - a. The deadline is currently set for late october.
 - b. The official due date is set to be emailed once it is completely decided.
 Until then, you have from 1-3 months to work on this project.
 - c. The deadline may be changed.
- 6. Winner Selection
 - The submissions will be reviewed by our panel of judges and the winners will be notified via email.

b. The winner's submission may also be placed on our website.

7. Prizes

- a. The winner's submission is placed on the website.
- b. The winners receive certificates for authenticity.
- c. The winners will also receive cash prizes.

8. Entry Conditions and Release

By entering, participants agree to the following conditions and release: Each Contestant agrees to comply with and be bound by these Official Rules and the Competition judges which are binding and final in all matters relating to this Competition.

9. Publicity and Intellectual Property

Except where prohibited, participation in the Competition constitutes the participant's consent to Administrators' and their agents' use of the winner's name, likeness, photograph, voice, opinions, and city for promotional purposes in any media without further consideration.

10. General Conditions

Administrators reserve the right to cancel, suspend and/or modify the Competition, or any part of it, if any fraud, technical failures or any other factor beyond the Administrator's reasonable control impairs the integrity or proper functioning of the Competition, as determined by Administrators in their sole discretion. Administrators reserve the right in their sole discretion to disqualify any individual or Competitor they find to be tampering with the entry process or the operation of the Competition or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner

11. Limitations of Liability

If for any reason an entrant's Submission is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, the entrant's sole remedy is to provide another submission.

1. Any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Competition;

 2. Technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software;
 3. Unauthorized human intervention in any part of the entry process or the Competition;

4. Technical or human error which may occur in the administration of the Competition or the processing of entries; or

5. Any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the entrant's participation in the Competition or receipt or use or misuse of any prize.
